### RATIONALE

At Assumption Catholic Primary School, we are committed to fostering a positive respectful learning environment for all students. Our Good Standing Framework acknowledges and rewards exemplary student attitude, behaviour, work ethic and effort, as well as providing a structure for addressing disciplinary matters.

### Good Standing Status

All students will commence each year with Good Standing. A student will be considered in Good Standing unless they accumulate three Extended Reflection Times or receive one suspension.

### Maintaining Good Standing Requires Students To:

- Adhere to the Assumption Catholic Primary School values, standards and expectations as outlined in the Student Engagement & Behaviour Procedure.
- Complete all classwork and activities with a positive attitude.
- Behave in a way that is respectful of staff and students' rights (see PBS Matrix).
- Maintain satisfactory attendance (above 90%) and punctuality. Satisfactory attendance is deemed to be full-time attendance at school, or in the event of an absence, a satisfactory explanation of the absence.
- Adhere to the ACPS School Uniform Guidelines.
- Adhere to the ACPS ICT Use by Students Policy.

### Extended Reflection Times

As set out in the Student Engagement & Behaviour Procedure, students displaying major behaviours, or repeated minor behaviours, may be given an Extended Reflection Time at the discretion of the Executive Leadership Team.

### Individual Behaviour Management Plans (IMBP)

Students on Individual Behaviour Management Plans' involvement in school activities held off-site will be at the discretion of the Executive Leadership Team, in consultation with the class teacher.

## Loss of Good Standing

A student will lose their Good Standing if they accumulate three (3) Extended Reflection Times or one (1) suspension within a ten-week period. This means they will not be able to represent the school in extracurricular events, or participate in Good Standing Activities and Roles including but not limited to:

- Interschool events
- School camps
- Discos
- Graduation celebrations
- Performing arts events
- Big Day Out
- Student Leadership roles
- Identified activities, incursions and excursion:
  - **Please note:** *Incursions and excursions are usually part of the curriculum and generally will not be Good Standing events/activities unless otherwise identified and communication with staff, parents and students prior to the event.*

## Notification of Loss of Good Standing

At the time of losing Good Standing, parents will be notified by phone call and requested to attend a meeting with an Assistant Principal. They will also be informed in writing via SEQTA Engage detailing the reasons for the loss of Good Standing and the requirements for its reinstatement.

## Regaining Good Standing

On the first instance, to regain Good Standing a student must achieve ten (10) consecutive school days of positive behaviour. In the second instance, they must achieve twenty (20) consecutive school days of positive behaviour. Students' behaviour will be tracked across each lesson during the day. To achieve a day of positive behaviour, a tick (satisfactory effort/behaviour) must be obtained for each lesson. Class and Specialist teachers will award a rating for each of their lessons. Upon the completion of the Good Standing period, an Assistant Principal will meet with the class teacher, parents and student to discuss the reinstatement and conditions of Good Standing.

## Loss of Reward

Students who have lost their Good Standing throughout the term, despite whether they have earned it back or not, will not participate in the next PBS whole school reward.

## Student Leadership and Good Standing

The first time a Student Leader, Councillor or House Captain loses their Good Standing status, they will temporarily lose their badge and their privilege to represent the school or House until their Good Standing is reinstated. Should this occur a second time (Loss of Good Standing), their privilege to represent Assumption Catholic Primary School as a Student Leader, Councillor or House Captain will be revoked for the remainder of the year.

### **Big Day Out**

All students who maintained their Good Standing status throughout the year will be invited to participate in the Big Day Out at the end of the year. If a student loses their Good Standing status three (3) times throughout the year, they will not be permitted to attend.

If a student does not have Good Standing at the time of the Big Day Out, but it is not their third loss, they may still attend at the discretion of the Executive Leadership Team.

### **Review and Appeals**

The Good Standing Framework will be reviewed biennially to ensure its effectiveness. Parents and carers may appeal decisions regarding Good Standing in accordance with the Assumption Catholic Primary School Dispute and Complaints Procedure.
